WHEREAS, Hammonton Road between Hammonton Smartsville Road and Timbuctoo Road is a public right of way confirmed by Yuba County Superior Court Decision No. CV 99-0000265; and

WHEREAS, Hammonton Road provides access to public and private lands commonly referred to as the Yuba Goldfields; and

WHEREAS, the Yuba Goldfields area is experiencing excessive ámounts of continual criminal activity and illegal dumping on the lands accessed via Hammonton Road; and

WHEREAS, California Vehicle Code Section 21101.4 allows for the gating of a public road for an 18 month duration when certain conditions are satisfied; and

WHEREAS, in 2022 the Yuba County Sheriff's Department received 83 call for service in the Yuba Goldfields area, and estimated 50 of which could have been avoided had Hammonton Road been gated; and

WHEREAS, in 2022 the California Department of Fish & Wildlife issued 315 citations in the Yuba Goldfields area, an estimated 145 of which could have been avoided had Hammonton Road been gated; and

WHEREAS, the gating of Hammonton Road will reduce or minimize the following types of crimes that are currently being witnessed: illegal dumping, illegal trespass, illegal firearms, operating vehicles in a manner likely to cause damage, unlicensed or suspended drivers, abandoned vehicles, vehicle fires, assaults with deadly weapons, and illegal drug use.

WHEREAS, the Board of Supervisors held a public hearing on the 11th and 25th days of July, 2023, allowing public comment about the gating of Hammonton Road pursuant to Vehicle
