- 2. Your completed Statement must be received by Yuba County Elections, where you are registered to vote, no later than 5 p.m. two days prior to certification of the election.
- 3. You must sign your name and provide your address where indicated below on this Statement.
- 4. Return your completed Statement in the postage-paid return envelope included with these instructions or use your own mailing envelope addressed to Yuba County Elections. Mail, deliver, or have your completed Statement delivered to Yuba County Elections. If you mail your completed Statement using your own envelope, be sure there is sufficient postage and that the address is correct. *See back of form for additional information.*
- 5. If you do not wish to send your completed Statement by mail or have it delivered, you may submit your completed Statement by email or fax to Yuba County Elections. You may also submit your completed Statement to a polling place within the county or a ballot drop-off box before the close of the polls on Election Day.
- 6. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.
