

**NOTICE OF RIGHT TO CLAIM EXCESS PROCEEDS
FROM THE SALE OF TAX-DEFAULTED PROPERTY**

Made pursuant to Section 4676, Revenue and Taxation Code

For any excess proceeds that may have resulted from the sale of the tax-defaulted property on February 2014, parties of interest, as defined by California Revenue and Taxation Code Section 4675, are entitle to claim the excess proceeds.

All claims must be in writing and must contain sufficient information and proof to establish a claimant's right to all or any part of the excess proceeds. Claims filed with the county more than one year after the recordation of the Tax Collector's deed to the purchaser on March 13, 2014, cannot be considered. Claims must be received prior to March 12, 2015.

Parties of interest shall be notified be certified mail prior to 05/24/2014. Notice of Excess Proceeds shall be published in the Appeal Democrat in May 2014.
